**Recruitment of Programmer Batch 2012 on Regular basis**

1. Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited, Jabalpur has been incorporated to undertake activities of distribution and retail supply of electricity in the State of M.P.
2. The Company intends to recruit Programmer on Regular basis and invite applications from the eligible candidates. The category wise vacancy positions is as under:

**3. RESERVATION:**

- 3.1. The reservation of posts meant for SC / ST / OBC / Physically Handicapped shall be applicable only for the candidates of Madhya Pradesh Domicile. Such candidates shall be required to submit a proof of Domicile in M.P.
- 3.2. Horizontal reservation for physically handicapped person will be provided as per the rules and order of GoMP based on the vacancies & roster.
- 3.3. For application of reservation, the state level roster shall be followed.
- 3.4. For availing the benefits of reservation and age relaxation, the candidates shall be required to produce Service Certificate / Death certificate of Husband/legal proof of divorce/Medical Certificate / Caste Certificate issued by competent authority / SDO (Revenue) of concerning jurisdiction.

**4. HOW TO APPLY (Please read the instructions carefully):**

- 4.1. Applications shall be received through M.P.online ([www.mponline.gov.in](http://www.mponline.gov.in)) only. Links to the website of MP Online have also been provided on the website [www.mpez-electricity-discom.nic.in](http://www.mpez-electricity-discom.nic.in)

**5. APPLICATION FEE & OTHER CHARGES:**

- 5.1. Application fees for unreserved / OBC category candidates of MP domicile and candidates of all categories belonging to other States shall be Rs. 500/- and SC / ST / Handicapped candidates of M.P domicile Rs. 250/- per candidate.

- 5.2. The applications are to be submitted only through MP Online Kiosks and the payment can be made in cash at the Kiosk. The portal charges shall be Rs. 60/- per application for all categories. Application submitted by any other means shall not be entertained.
- 5.3. No extra charge shall be payable for scanning of photograph etc. to Kiosk apart from the portal charges.

## 6. QUALIFICATION CRITERIA:

- 6.1. The candidate should be a MCA or B.E. / B.Tech in Computer Science / Electronics & Communication Engineering / Information Technology (or any equivalent graduate degree in relevant branch of engineering) from a Institute recognized by AICTE or a University recognized by University Grants Commission, with
- 6.1.1 Minimum 65% marks in aggregate in case of General / Unreserved and OBC category candidates of M.P.Domicile and candidates of all categories not having M.P. Domicile.
- 6.1.2 Minimum 55% in case of SC / ST category candidates having M.P. Domicile.
- 6.2. The candidates having MCA or B.E. / B.Tech in Computer Science / Information Technology (or any equivalent graduate degree in relevant branch of engineering) should also have following certification (Any one of these):
- (i) Sun Certified Java Programmer (SCJP)/ Sun Certified Java Developer (SCJD)
- (ii) Oracle Certified programmer (OCP)
- (iii) Microsoft Certified Solution Developer (MCSD)

### OR

The candidates having B.E. / B.Tech in Electronics & Communication Engineering should be CCNA Certified.

- 6.3. The candidates appearing in Final Semester / Year examination may also apply, however, the candidates if selected for interview shall have to produce the proof of having passed the final year / semester examination with minimum stipulated qualifying marks for the respective category before appearing for personal interview failing which their candidature shall be cancelled.

## 7. AGE LIMIT:

The age of candidates as on 30-06-2012 should be

- 7.1. Minimum age limit: **21** years

- 7.2. Maximum age limit: 30 years
- 7.3. Candidates belonging to SC / ST / OBC / Handicapped categories, widow / Divorcee lady candidates / Ex. Serviceman will get relaxation in upper age limit to an extent of five years.

## **8. DOCUMENTS TO BE FURNISHED AT THE TIME OF INTERVIEW:**

The candidates short listed for interview shall be permitted to appear for interview only after verification of the following original certificates / documents about their eligibility:

- 8.1. Higher Secondary or High School Examination certificate in support of date of birth,
- 8.2. B.E./B.Tech./ MCA Degree course mark sheet for every year / semester of education.
- 8.3. B.E./B.Tech / MCA Degree certificate (provisional, if final degree not received).
- 8.4. Certificate of service in case of ex serviceman.
- 8.5. Caste certificate, (in case of reserved category candidates) issued by concerned Sub Divisional Officer (SDO),
- 8.6. Certificate of disability (in case of handicapped persons) issued by District Medical Officer,
- 8.7. Domicile certificate, in case of candidates applying for reserved posts,
- 8.8. Candidates serving in government / semi government / public sector organisation should submit N.O.C. from their present employer,
- 8.9. Photo identity proof i.e. Passport / Driving license / Voter ID / Bank pass book.
- 8.10. Proof of permanent address.
- 8.11. Widow / Divorcee lady should submit death certificate / legal proof applicable.

## **9. SELECTION PROCESS:**

- 9.1. The eligible candidates will have to undergo a written test comprising of questions on Information Technology, Computer Science, Logical Reasoning, General Aptitude and General awareness.
- 9.2. Admit cards for written test will be available online on [www.mponline.gov.in](http://www.mponline.gov.in). Candidates are to download the admit card from the given website.
- 9.3. The written test will be of 2 hours 30 minutes duration.
- 9.4. The question paper will be in English and consisting of objective type (multiple choice) questions.
- 9.5. The center for written test will be at Indore only.
- 9.6. Based on performance in the written test, candidates shall be called for Personal interview.

## **10. SELECTIONS AND APPOINTMENT:**

Based on the marks obtained in written test and interview, final merit list will be prepared giving 80:20 weightage to candidates for marks obtained in the written test

and interview and candidates shall be selected for appointment to the post of Programmer from the merit list.

**11. SALARY:**

On regular appointment as Programmer, he / she shall be absorbed in the pay scale having basic pay Rs. 15,600 + other allowances as specified in the Wage Structure of the Company. The appointed Programmer shall be eligible for the New Defined Contributory Pension Scheme.

**13. GENERAL INSTRUCTIONS:**

- 13.1. The Candidate should be an Indian National.
- 13.3. All SC / ST / Handicapped candidates will be reimbursed to and fro ordinary second class rail fare by the shortest route for appearing in the written test and personal interview. For places where rail facility is not available, bus fare by the shortest route will be paid. Such candidates shall have to produce copy of caste certificate/disability certificate and proof of journey.
- 13.4. Any dispute arising out of the selection process shall be dealt within the jurisdiction Courts situated only at Jabalpur.
- 13.5. The minimum degree of disability in order for a handicapped person to be eligible for any concessions / benefits would be 40%.
- 13.6. The candidates must produce original documents / certificates at the time of interview in support of their qualification and experience (if any) for verification.
- 13.7. The vacancies are tentative and may change at a later date according to the need of the company. The company reserves the right to fill or not to fill any of the vacancies.
- 13.8. The candidate shall be required to work anywhere in the jurisdiction of the company's area.
- 13.9. The appointment letter to the candidates will be issued on the basis of merit list.
